

## Changes within the Well Drilling Section of the Nevada Water Resources

I would like to take this time to inform you of a few changes in the Well Drilling Section here at the Nevada Division of Water Resources. As some of you know, Hamilton Reed has retired. Ken Haffey (775-684-2814) was promoted to Hamilton's former position and is now handling most of the waiver duties. Shannon McDaniel (775-684-2842) has taken Ken's duties in the Well Drilling section and she will be responsible for processing all well driller license applications and examinations. Lastly, Amanda Brownlee has promoted to the Water Rights section and her vacancy has been filled by Jake Echeverria (775-684-2813). Jake will still be handling the reviewing/processing of all NOI's and well logs, as well as field investigation. As for me, I can still be reached at 775-684-2838 and am happy to help in any way I can.

I am also pleased to inform you that Andy Andresen has accepted and filled the empty Well Driller Advisory Board Seat. This left two vacancies on the Advisory Board for alternates. Upon reviewing all of the qualified candidates, we are pleased to announce that Steve Loughry and Manuel Quinones II have both accepted the alternate positions. Steve is employed with Allied Drilling Corp. out of Winnemucca, Nevada, and has held a Nevada Well Driller's license since April 11, 1988. Manuel is employed with Eagle Drilling Services and has held a Nevada Well Driller's license since May 17, 2004. We would like to thank everyone for their interest in becoming a board member.

As you can see, there have been quite a few changes at the Nevada Division of Water Resources Well Drilling Program. We are striving toward making this a better program, and we ask that if you have any thoughts, ideas or concerns, give us a call so that we may address those issues.

### Required Courses Have Changed

The required regulation workshop has been changed to one four hour course, three hours covering the regulations portion and one hour covering the forms portion. All workshops are scheduled from 8:00 am to noon. You will receive 4 Continuing Education Units (CEU's) for attending this workshop.

## 2016 Examination Dates and Times

Written exams for parts I and II of the well driller examination are offered on the third Thursday in January, March, April, June, July, September, October and December. The exam will begin promptly at 8:30.

The Statewide Well Driller's Advisory Board meets in February, May, August and November to conduct part III of the well driller examination. The oral exam is scheduled by appointment.
